

2. APPROVAL OF RESOLUTION NO. R-25-12, ADOPTING A LIST OF STREET PROJECTS FOR FISCAL YEAR 2025-26 FUNDED BY SB1, THE ROAD REPAIR AND ACCOUNTABILITY ACT OF 2017

Recommendation: Staff recommends the City Council approve Resolution No. R-25-12, adopting a list of fiscal year 2025-26 SB 1 projects. If the City Council concurs with staff's recommendation, an appropriate motion would be:

"I move to approve Resolution No. R-25-12 adopting a list of Fiscal Year 2025-26 projects to be funded by SB 1 Road Maintenance and Rehabilitation Account Funds."

RESOLUTION NO. R-25-12

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SAN MARINO, CALIFORNIA, ADOPTING A LIST OF PROJECTS FOR FISCAL YEAR 2025-26 FUNDED BY SB 1: THE ROAD REPAIR AND ACCOUNTABILITY ACT OF 2017

WHEREAS, Senate Bill 1 (SB 1), the Road Repair and Accountability Act of 2017 (Chapter 5, Statutes of 2017) was passed by the Legislature and Signed into law by the Governor in April 2017 to address the significant multi-modal transportation funding shortfalls statewide; and

WHEREAS, SB 1 includes accountability and transparency provisions that will ensure the residents of the City are aware of the projects proposed for funding in the community and which projects have been completed each fiscal year; and

WHEREAS, the City must adopt by resolution a list of projects proposed to receive fiscal year funding from the Road Maintenance and Rehabilitation Account (RMRA), created by SB 1, which must include a description and the location of each proposed project, a proposed schedule for the project's completion, and the estimated useful life of the improvement; and.

WHEREAS, the City, will receive an estimated \$329,219 in RMRA funding in Fiscal Year 2025-26 from SB 1; and

WHEREAS, this is the ninth year in which the City is receiving SB 1 funding and will enable the City to continue essential road maintenance and rehabilitation projects, safety improvements, repairing and replacing aging bridges, and increasing access and mobility options for the traveling public that would not have otherwise been possible without SB 1; and

WHEREAS, the City has conducted a robust public process to ensure public input into the community's transportation priorities/the project list, including approval of this resolution at the City Council meeting held on May 14, 2025; and

WHEREAS, the City used a Pavement Management System to develop the SB 1 project list to ensure revenues are being used on the most high-priority and cost-effective projects that also meet the community's priorities for transportation investment; and

WHEREAS, the funding from SB 1 will help the City reconstruct, maintain and rehabilitate streets and roads throughout the City this year and similar projects into the future; and

WHEREAS, the 2023 California Statewide Local Streets and Roads Needs Assessment found that the City's streets and roads are in good condition and this revenue will help us increase the overall quality of the City's road system and over the next decade will bring the City's streets and roads into an excellent condition; and

WHEREAS, the SB 1 project list and overall investment in the City's local street and road infrastructure with a focus on basic maintenance and safety, investing in complete streets infrastructure, and using cutting-edge technology, materials and practices, will have significant

positive co-benefits statewide.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of San Marino, California as follows:

SECTION 1. The foregoing recitals are true and correct

SECTION 2. The following list of newly proposed projects will be funded in-part or solely with Fiscal Year 2025-26 Road Maintenance and Rehabilitation Account revenues:

A. Local Street Rehabilitation Project 25-9271; which involves the resurfacing of the following streets:

- a. Afton Road from S Oak Knoll Avenue to West City limits
- b. Courtland Avenue from Oak Knoll Avenue to Monterey Road
- c. Huntington Drive W/B from Virginia Road to N Granada Avenue
- d. Kenilworth Avenue from Huntington Drive to Melville Drive
- e. Oak Knoll Avenue from Sherwood Road to Darby Road
- f. Roanoke Road from Ridgeway Road to Del Mar Avenue
- g. Roanoke Road from St Albans Road to Virginia Road

This project has a 20-year estimated useful life; to be constructed beginning in April 2026 and ending in June 2026.

B. Street Sweeping – Citywide; which involves the mechanical sweeping of residential and arterial/collector streets throughout the City on a weekly basis (52 times per year). Services will be obtained in compliance with the procurement requirements set forth in the City’s Municipal Code related to goods and services.

This project has a 1-year estimated useful life, and will occur from July 2025 to June 2026.

SECTION 3. The following previously proposed and adopted projects may also utilize Fiscal Year 2025-26 Road Maintenance and Rehabilitation Account revenues in their delivery. With the relisting of these projects in the adopted fiscal year resolution, the City is reaffirming to the public and the State our intent to fund these projects with Road Maintenance and Rehabilitation Account revenues:

A. Local Street Rehabilitation Project 24-9271; which involves the resurfacing

of the following streets:

- a. Duarte Road from Hilliard Drive to San Gabriel Boulevard
- b. Ridgeway Road from Huntington Drive to Roanoke Road
- c. Ridgeway Road from Melville Drive to Adair Street
- d. Ridgeway Road from Adair Street to Sherwood Road
- e. San Marino Avenue from Adair Street to Sherwood Road
- f. San Marino Avenue from Sherwood Road to Lorain Road
- g. Somerset Place from Wellesley Road to East City Limit
- h. Virginia Road from Rosalind Road to Circle Drive

This project has a 20-year estimated useful life; to be constructed beginning in April 2026 and ending in June 2026.

SECTION 4. The City Clerk shall certify to the adoption of the resolution and shall cause a certified resolution to be filed in the book of original resolutions.
